6/11/56 Appointed Assistant at St. Helen's Parish in Milwaukee, WI effective June 26, 1956. (23761)

### 6/26/56 – Assistant, St. Helen's, Milwaukee, WI

8/31/61 Appointed Assistant at St. Mary's Parish in Menomonee Falls, WI effective September 21, 1961. (23762)

### 9/21/61 – Assistant, St. Mary's, Menomonee Falls, WI

7/3/62 Appointed Assistant at St. Hedwig's Parish in Milwaukee, WI effective July 12, 1962. (23763)

### 7/12/62 – Assistant, St. Hedwig's, Milwaukee, WI

11/13/63 Appointed part-time religion teacher at St. John's Cathedral High School. (23764)

### 11/13/63 – Religion Teacher, St. John's Cathedral High School

6/21/65 Appointed Curate at St. Joseph Parish in West Allis, WI effective July 7, 1965. (23767)

### 7/7/65 – Curate, St. Joseph Parish, West Allis, WI

9/8/65 Appointed Instructor of Religion at Pius XI High School in Milwaukee, WI. (23768)

### 9/8/65 – Instructor of Religion, Pius XI High School, Milwaukee, WI

6/24/66 Appointed Curate at St. Paul's Parish in Milwaukee, WI effective July 6, 1966. (23769)

### 7/6/66 – Curate, St. Paul Parish, Milwaukee, WI

8/22/66 Letter from Budzynski to Cousins requesting that he be assigned to work in guidance counseling or teaching. Mentions that he would like to take education courses at Marquette, or possibly help to fill the urgent need for priest marriage counselors. Also mentions that he has some experience counseling youth from his work at a camp in Michigan in the past, and as a result, "I have since been especially interested in helping boys." (23770)

5/23/69 Appointed Associate Pastor at St. Casimir Parish in Milwaukee, WI effective June 17, 1969. (23720)

6/17/69 – Associate Pastor, St. Casimir, Milwaukee, WI

8/22/69 Appointed part-time instructor of religion at St. Joan Antida High School in Milwaukee, WI. (23772)

8/22/69 – Part-time Religion Instructor, St. Joan Antida High School, Milwaukee, WI

9/15/71 Appointed Associate Pastor Pro Tem at St. Bernadette's Parish in Milwaukee, WI effective September 28, 1971. (23719)

9/28/71 – Associate Pastor Pro Tem, St. Bernadette, Milwaukee, WI

11/3/72 Appointed Associate Pastor at St. Peter Claver Parish in Sheboygan, WI effective November 14, 1972. Also notes that Budzynski will assist with the CCD work at St. Mary's Parish in Sheboygan Falls, WI. (23716)

11/14/72 – Associate Pastor, St. Peter Claver, Sheboygan; Assist with CCD work, St. Mary, Sheboygan Falls, WI

8/27/73 Letter from Cousins to an unknown (redacted) man stating "be assured that we are as concerned as you yourself in this matter and we are making every possible effort to resolve justly and with charity the unfortunate situation as it presently exists." (23774)

9/14/73 Letter from Cousins to Budzynski stating that Budzynski should take a leave of absence and that there is a problem that has not been brought completely under control. Letter says that remaining in his present parish could induce publicity that should be avoided. Progress has been made, and more could be made without the pressures and criticisms of his present environment. Suggests that he move away from the Sheboygan area, that the treatment will not have value without Budzynski cooperating, and that Budzynski could have years ahead of him in ministry. (23777-23776)

3/4/74 Appointed Associate Pastor at St. Joseph's in Wauwatosa, WI. (23715)

3/4/74 – Associate Pastor, St. Joseph's, Wauwatosa, WI

5/1/76 Letter from Cousins to Budzynski granting a temporary leave of absence effective immediately "to permit the resolution of your current personal problem under the direction of [various doctors]." States he should be prepared to move into temporary residency by Friday May 7. Also explains that "the professional and medical approach to your problem is not to be primarily interpreted as disciplinary" and that "you represent a priestly potential that the Church of Milwaukee needs and plans to use for many years." (23779)

5/7/79 – Leave of Absence

7/9/76 Letter from Cousins to Bishop Freking stating that Budzynski will work in the Diocese of La Crosse in campus ministry and that Budzynski has had undefined problems, which have been brought to his attention and which are known to Fr.

Cook. Mentions Budzynski will continue to see a psychologist or psychiatrist. (23713)

7/9/76 Letter from Cousins to Budzynski releasing him for work in the Diocese of La Crosse effective August 1, 1976. (23714)

7/21/76 Letter from the Bishop of La Crosse to Cousins enclosing an official appointment of Budzynski to work in campus ministry at UW-Eau Claire and acknowledging Budzynski's circumstances and progress. (23784)

8/1/76 – Campus Ministry, UW-Eau Claire, Diocese of La Crosse, WI

2/3/77 Letter from Budzynski to Weakland from UW-Eau Claire stating that he wants to remain in Eau Claire for 3 to 5 years at least, says he has made a good decision and a fairly good transition, and noted that "I would be willing to share with you personally some of the circumstances which made me available for this work in the summer of 1976" if they meet again when Weakland comes to Eau Claire. (23797-23798)

2/11/78 Letter from Weakland to Budzynski thanking him for his letter and stating that he wasn't sure if he would see him when he went to La Crosse but that if Budzynski was in Milwaukee they could meet. (23794)

3/12/78 Letter from an Eau Claire doctor praising Budzynski, saying that his is one of the families in the Newman Community. Both families and students have taken a special liking to Budzynski, who has proven to be an understanding, empathetic, and effective counselor. (23808)

5/12/78 Letter from Weakland to the same doctor in Eau Claire thanking him for his letter on Budzynski. (23807)

11/28/81 Periodic review of Budzynski discussing his family background, path to the priesthood, time in the seminary, love of music, and constant desire for continuing education. Also says that he was candid in discussing the circumstances that led to his need for psychiatric and psychological counseling. He also discussed his bout with alcoholism. Although there is no complete "cure," as a result of treatment, Budzynski feels that he can now recognize the pressure points in his life. (23904-23906)

1/11/82 Vicar Log Entry No. 29. States that the Archbishop called to inform him of a report that Budzynski drank heavily at some friends' home over the weekend and made homosexual advances toward two of their boys. The boys were 13 and 18. (23877)

1/12/82 Vicar Log Entry. Author expresses worry about Budzynski, who explains difficulties he has had in dealing with the deaths of his parents, his drinking, and his "psycho-sexual problems." Budzynski was ashamed of his behavior over the weekend and agreed to go to treatment at the Guest House. He will tell the people

in Stevens Point that he is coming back to the Archdiocese of Milwaukee to work but that because of his health he is going to take an extended vacation. (23876)

- 1/12/82 Letter from Guest House in Rochester, MN to Janicki asking for background information about Budzynski for his referral to Guest House. (23924)
- 1/15/82 Vicar Log Entry No. 51. Budzynski beginning treatment for personal problems. (23876)
- 1/19/82 Letter from Janicki to Guest House answering questions and saying that Budzynski had extensive counseling for “psycho-sexual problems” in the past, but has not had any treatment for alcoholism. Notes that the psycho-sexual problems invariably occur after drinking. The incident that led to his referral to Guest House was also brought on by heavy drinking, which led to Budzynski’s solicitation of two young boys. His psycho-sexual problems had serious consequences and led to transfers from parishes and to another diocese. (23922-23923)
- 1/26/82 Letter from Janicki to Bishop Freking of La Crosse. Budzynski has experienced personal difficulties in the past month and has voluntarily checked in to Guest House. After his treatment he will in all likelihood return to the Archdiocese of Milwaukee. It has been profitable for him to stay in his current assignment despite the recent problems. (23928)
- 1/27/82 Letter from Bishop Freking of La Crosse regarding paying for Guest House. Commends Archdiocese for its handling of the situation. Mentions that Freking thought Budzynski was doing reasonably well, although there were one or two suspicious episodes. Freking regrets losing Budzynski. (23927)
- 4/6/82 Letter from Guest House to Weakland informing him that Budzynski has “no significant psychopathology that could not be construed as resulting from progressive alcoholism, but which is completely reversible in continuing sobriety.” (23935-23936)
- 5/12/82 Guest House aftercare plan signed by Budzynski. Calls for him to abstain from alcohol, seek a sponsor, return to Guest House for follow-up, and other behavior to avoid drinking again. (23938-23939)
- 8/12/82 Appointed Pastoral Team Member at St. Patrick Parish in Whitewater, WI effective September 1, 1982. (23822)
- 9/1/82 – Team Member, St. Patrick, Whitewater, WI
- 6/6/83 Vicar Log Entry No. 513. Budzynski’s reports that his therapist thinks he could handle a parish assignment as long as someone else handled the work with high school students and younger people. (23874)
- 6/8/83 Vicar Log Entry No. 528. Author recommends Budzynski for an appointment based on his past satisfactory work in campus ministry. A doctor who the author

spoke with received “negative vibes” about Budzynski from other priests, in particular regarding poor performance and personal problems. Budzynski’s therapist thinks it may not be good for Budzynski to work with young children, boys or girls, and recommends parish work instead. Based on that recommendation, author says he will explore the possibility of Budzynski becoming an associate at St. Vincent’s. (23874)

9/1/83 – Temporary Administrator, St. James, Mukewonago, WI

9/21/83 Appointed Temporary Administrator of St. James Parish in Mukewonago, WI retroactive to September 1, 1983. (23709)

9/28/83 Budzynski approved to take a sabbatical to pursue continuing education in the spring of 1984. (23944)

1/84-5/84 – Sabbatical

4/28/84 Letter from Budzynski to Gene Newman acknowledging that he has serious and personal reasons for avoiding any large school population, and that given his “past experiences,” he would prefer an assignment to a parish where there is less emphasis on the school. He saw a psychologist almost weekly during sabbatical and that he was alerted to his “continuing fragility and vulnerability in certain areas (alcohol, self-esteem, workaholic, youth, etc.)” Recognizes he needs to continue ongoing therapy, which has helped him considerably in recent years. (23826)

4/28/84 Letter from Budzynski to Weakland thanking him for the opportunity to take a sabbatical and thanking him for all he has done for the Archdiocese of Milwaukee, in particular his “concern for you sick priests.” (23824)

6/19/84 Appointed Associate Pastor of St. Louis Parish in Caledonia, WI. (23708)

6/19/84 – Associate Pastor, St. Louis, Caledonia, WI

9/4/84 Appointed Pastor at St. Louis Parish in Caledonia, WI effective September 4, 1984. (23707)

9/4/84 – Pastor, St. Louis Parish, Caledonia, WI

6/4/85 Letter from Budzynski to Sklba discussing his aftercare and saying, “I assume you are aware of my medical treatment/recovery programs, or have some kind of access to the file.” He participates in A. A. and continues in monthly counseling. (23953)

9/6/86 Vicar Log Entry No. 447. Sklba met with Budzynski, who feels like his alcoholism and sexuality is properly under control with therapy and there had been no problems at the parish in either area. (23872)

10/10/86 Vicar Log Entry No. 509. Sklba met with Budzynski’s therapist to discuss his progress. Therapist says he has made great progress and, as a result, can be

expected to continue in his ministry without undue risk provided he follow the personal precautions that have been established, avoid alcohol, and continue his monthly therapy sessions.

- 6/13/87 Vicar Log Entry No. 282. Sklba received a call from the St. Louis Parish Council President regarding alleged child abuse. Sklba called Budzynski and his therapist. Sklba also heard of another parent who expressed concern. (23872)
- 6/16/87 Vicar Log Entry No. 286. Sklba spoke with Budzynski's therapist, who talked with Budzynski about the possibility of child abuse. Sklba said he would feel constrained to make a report to the Racine police department and raised the possibility of Budzynski moving from the assignment. (23871)
- 6/30/87 Vicar Log Entry No. 320. Sklba had a conversation with Budzynski's therapist and said that an increasing number of parents are very concerned. Sklba has received indication that two others may have had some questionable experiences leaving them confused during the past year. "I have become convinced that a change this summer seems most appropriate." (23870)
- 7/22/87 Vicar Log Entry No. 364. Sklba met with Budzynski and his therapist and strongly suggested reassignment. Sklba also met with an eighth grade boy and the boy "endorsed a brief description of the event" that Sklba narrated. Boy tells Sklba that "adults are making a bigger issue of this than necessary." Boy's parents request that Sklba not contact the police. (23870)
- 8/10/87 Vicar Log Entry No. 388. Sklba spoke to Budzynski, who said he would apply for chaplain position at the motherhouse and Sklba called the convent administrator and recommended they consider him. (23870)
- 8/22/87 Vicar Log Entry No. 427. Sklba called Budzynski about the chaplaincy position and encouraged him to let others know informally that he had been invited to interview for another pastoral position in the Archdiocese. (23870)
- 8/28/87 Vicar Log Entry No. 433. Sklba met with Budzynski and encouraged his speedy movement into new ministry at the motherhouse and asked him to consider possible parish residences and to offer help out work at his St. Louis. (23869)
- 9/2/87 Appointed Priest Team Member of St. Francis of Assisi Convent/St. Ann Center in Milwaukee, WI effective October 19, 1987. (23701)
- 9/22/87 Vicar Log Entry No. 488. Sklba had a meeting with Sr. Rita Jean, the principal at St. Louis School regarding gossip in the parish and affirming everything he had done in his pastorate there. The principal was concerned that the entire matter could be unfairly handled to Budzynski's disadvantage. (23869)

10/19/87 – Priest team member, St. Francis of Assisi Convent/St. Ann Health Center, Milwaukee, WI

- 10/30/87 Letter from Sklba to Budzynski welcoming him to his new work assignment. He hopes they will be able to cross paths so that the healing of any pain associated with Budzynski's departure might be accompanied by ongoing support for his ministry and spiritual growth. (23965)
- 4/3/92 Letter from Budzynski to Sklba. He is still in therapy, which is an important element of his sobriety, as well as helping control his behavior. He recognizes that he is still vulnerable, but is able to work tensions and frustration out through his therapy sessions. (24005-24006)
- 9/30/92 Appointed Chaplain at Villa Clement Health Care Center in Greenfield, WI effective October 15, 1992. (23679)
- 10/15/92 – Chaplain, Villa Clement Health Care Center, Greenfield, WI
- 8/9/93 Letter from Budzynski to Venne updating him on how Budzynski is doing. He is still in therapy about once per month and has maintained his sobriety since 1982 by following the A.A. program. Happy with his progress, as well as his assignment, ministry, and living arrangements. (24015-24016)
- 1/21/94 Sexual abuse intake report alleging four incidents of abuse by Budzynski of a girl in 1970-1971 at St. Bernadette. Two of the three incidents involve an older woman bringing the victim to Budzynski. (35740)
- 2/1/94 Vicar Log Entry No. 135 re: intake report of 1/21/94. Piasecki and Venne met with Budzynski and told him of a woman's recent allegations of inappropriate behavior when she was in first grade in 1970-1971, that the woman had contacted a lawyer and that Budzynski would contact Matt Flynn. Budzynski has no recollection of any of the alleged incidents. (23866)
- 2/9/94 Allegations against Budzynski re: intake report of 1/21/94. A woman reports abuse by Budzynski in 1970-1971 that she recalled one year prior in treatment. She believes that Fr. James Ruetz must have known. (23742)
- 2/10/94 Handwritten history of Budzynski includes: notes "St. Bernadette – intervention Fr. James Ruetz, Parents, Bp. Brust – no incident," intervention during assignment at St. Joseph from 1974-1976, 1978- "Eau Claire – Fr. Janicki intervention," and on leave for treatment in 1973-1974. (23739-23741)
- 3/22/94 Letter from Budzynski to Gina at Villa Clement Health Center informing her of his intent to retire. (23678)
- 4/14/94 Letter from Budzynski to Weakland asking for permission to retire. (23835)
- 4/21/94 Letter from Weakland to Budzynski accepting Budzynski's request for retirement. (23676)
- 4/21/94 Letter from Weakland to Budzynski saying that it would be very important for him not to have any contact with minors that is not totally supervised. Also cautions Budzynski about help out work and that they should come to an

agreement about how and when it takes place. Can say Mass privately or concelebrate publicly. (23837)

5/4/94 Vicar Log Entry No. 261. Sklba states that he spoke to Budzynski and approved him to continue doing monthly help-out at St. Leonard's in Muskego because the priest there is completely aware of the history. (23865)

5/24/95 Vicar Log Entry No. 382. Sklba notes a report that Budzynski celebrates an occasional Sunday Eucharist under strict supervision at St. Leonard Parish in Muskego and assists every other weekend at Elm Brook Hospital. Told Sklba that the next Pastor at St. Leonard's should be informed of Budzynski's need for continued supervision. (23864)

5/25/95 Letter from Weakland to Budzynski stating that he is reviewing the situation of priests with allegations of misconduct and his concern is both to ensure that the integrity of the priesthood is upheld and to protect the diocese from any allegations of improper monitoring that might place persons at risk. (23840) Includes a precept saying that Budzynski is to refrain from all contact with minors, cease public ministry, and avoid situations that have been occasions of serious temptation in the area of sexual morality, and not to hear confessions. (23841)

5/31/95 – Retired

6/8/95 Letter from Budzynski to Weakland questioning the sudden and severe decision preventing him from public ministry. He is perplexed because of the many years without any public notice and considering that each incident was resolved with the Bishop and families. Points out that he has always done what the Church asked of him and promises continued obedience. (23843)

6/21/95 Letter from Weakland to Budzynski apologizing for his abrupt letter but noting that any public ministry exposes him, the priesthood, and the diocese to negative publicity. He writes that the network of victims is well organized and any public ministry becomes the occasion for renewed anger and threats. Weakland wishes he could be more generous, but cannot because the exposure is too great and the possible consequences too devastating. (23842)

7/25/95 Letter from Budzynski to Weakland saying that he has been receiving counseling for more than 20 years and has worked hard for years to resolve his difficulties. Also notes that he's been doing help out work at St. Leonard's for over 8 years and that since retirement he has ministered to convalescents at St. Francis Wood. He has now severed ties with all help out commitments. He is unclear how extensive the restrictions are so he asks for clarifications. (23845-23847)

8/22/95 Letter from Weakland to Budzynski saying that he does not believe that Budzynski understands the seriousness of the situation. Says Budzynski could be the object of enormous numbers of lawsuits if people come forward. Budzynski also doesn't understand the harm he's done to so many young people in Archdiocese. Writes that the harm is "greater than you can ever imagine."

- Weakland therefore concludes that he cannot foresee any way in which the restrictions on Budzynski can ever be lifted. (23844)
- 5/14/97 Letter from Sklba to Budzynski giving him “one time only” permission to preside and preach at the 50<sup>th</sup> anniversary of his cousin in Centerline, MI. (24035)
- 7/14/98 Letter from Budzynski to Sklba reviewing his history in the LaCrosse Diocese and some of his Milwaukee area assignments. He says he was recalled back to Milwaukee in 1992 because of an incident in Waukesha. Also mentions a foolish and unfortunate incident at a student retreat in St. Louis Parish that he referred to as “horsing around.” (24036-24037)
- 4/24/01 Letter from Budzynski to Weakland asking to perform a few ceremonies such as family weddings and his 45<sup>th</sup> ordination anniversary mass. States “I am chairman of the [anniversary] committee and most of my classmates are unaware of the fact that the Church had placed restrictions on my public Ministry.” Admits that he has had some serious difficulties in the past, but they go back almost twenty-five years and in each case he was confronted by Bishops, Pastors, and Parents and agreed to certain disciplines. “At no time was my name made public nor was it a matter for the legal authorities.” Has been participating in intensive psychotherapy for well over 20 years and has not had a drink in 19. (23850-23852)
- 5/7/01 Letter from Weakland to Budzynski saying that the serious difficulties of the past never surfaced in the public forum nor were brought to any legal authorities, but they still could surface. Public ministry would be a risk and it is still not an option for Budzynski. Concludes that it is “best to hold the status quo.” (23849)
- 4/6/02 Letter from unknown victim of Budzynski’s to Hornacek detailing a few interactions with Budzynski, which the victim did not consider “experience as a sexual assault or traumatic event.” and instead only offered as corroborating information in the event that Budzynski continued his behavior or it progressed into more serious actions.
- 4/15/02 Sexual abuse intake report alleging abuse by Budzynski of a 13 year old boy in approximately 1981. (123904)
- 8/8/02 Sexual abuse intake report alleging abuse of a 3<sup>rd</sup> grade boy by Budzynski at St. Paul’s Parish in 1967-1973. (24071-24072)
- 8/13/02 Letter from Barbara Anne Cusack to E. Michael McCann, District Attorney, enclosing materials for his review, including a report is against Budzynski, and noting that Budzynski is retired and under full restrictions. (23853)
- 2/3/03 Letter from Dolan to Budzynski confirming the restrictions placed on him in the previous precept. (23674)
- 7/15/03 Letter from Dolan to Cardinal Ratzinger at the CDF enclosing a summary of Budzynski’s case and asking that he be dismissed from the clerical state. States

that Budzynski has admitted to multiple acts of sexual assault. The Archdiocese tried treatment but he continued to reoffend. States that in at least one instance, he was simultaneously engaged in sexual activity with a young boy and his mother and her female friend. Says the impact on his various victims has been significant and the potential for true scandal is very real. (24131-24132) Also enclosed is a summary of the allegations. Lists multiple males that Budzynski admitted molesting during a 1994 investigation, sometimes including information related to the type of abuse and when the abuse occurred. States that the greatest risk posed is Budzynski's failure to recognize or accept the seriousness of his offenses. Budzynski makes assertions that these encounters were helpful to the children and they wanted them to take place. All cases reviewed by the Milwaukee County District Attorney's office. Has been restricted from all ministry since 1995. (24133-24145)

- 7/18/03 Letter from Dolan to Budzynski admonishing him for going on the Pallium Pilgrimage as a member of the Archdiocesan Choir, demanding that he sever all ties with the choir and the Priest Pension Review Board, and informing him that his case was sent to the CDF. (24050)
  
- 7/27/03 Letter from Budzynski to the man that reported to Fr. Hornacek on 4/6/02 apologizing for the devastating effects of the abuse. He says he was troubled at the time and didn't realize what he was doing. He entered a facility after to deal with his addiction and compulsion. (58398)
  
- 10/14/03 Letter from Archbishop Angelo Amato at the CDF to Dolan asking for clarification on the ages of Budzynski's victims. (23858)
  
- 10/28/03 Letter from Dolan to the CDF enclosing the ages of the victims at the time of abuse, their current ages in 2003, and their names. The ages were between 7 and 16 at the time of the abuse. Lists approximately 32 victims. (24164-24165)
  
- 12/18/03 Sexual abuse intake report alleging abuse at St. Bernadette by Budzynski of a 7 year old girl in 1971-1972. This is the woman who first reported on 1/21/94. Report indicates that the abuse survivor contacted Liz Piasecki in 1994. Abuse Survivor reports that her perception is that she elected not to make a report at that time because Liz Piasecki allegedly told her that any attempt to take legal action would be met with the Archdiocese's legal resources. Report also indicates that Liz Piasecki offered financial assistance with therapy, which was declined by the abuse survivor. Survivor has already reported this to the Milwaukee County District Attorney's Office. (35738)
  
- 3/18/04 Sexual abuse intake report alleging abuse of a boy at St. Joseph's in Wauwatosa by Budzynski in the early-mid 1970s. (23900)
  
- 10/13/04 Summary of an interview of young boy abused by Budzynski at St. Hedwig's in 1958-1960 that was initially reported 2-3 weeks ago. (57419-57420)
  
- 10/16/04 Summary of Archdiocese investigator's interview with Budzynski in response to allegations made in 10/13/04 interview. He admitted to 3 instances of abuse of

children and also to being reported to the Archdiocese for child abuse on several occasions. Says he sought treatment in 1970-73 for his problems without telling his family or the Archdiocese and then later treated with another therapist from 1975-1995. (57421-57422)

10/29/04 Letter from the CDF dismissing Budzynski from the clerical state. (24168-24169)

10/29/04 – Laicized

- 1/17/05 Settlement agreement with a male Budzynski victim for \$100,000 based on allegations of abuse at St. Joseph Parish. (57084-57086)
- 2/1/05 Settlement agreement with a male Budzynski victim for \$70,000. (57081-57083)
- 4/29/05 Statement from the survivor who reported to Fr. Hornacek on 4/6/02 detailing his abuse by Budzynski. He's meeting with the Archdiocese to try to move on with his life. Also includes a statement from the survivor's wife. (57573-57578)

Curt Frederick to various pastors informing them that Daniel Budzynski is living near them, that he is not allowed to do any ministry and has been laicized, and that if he is found to be conducting any "ministry," he should be reported to local civil authorities. (24051-24053)
- 1/26/06 Sexual abuse intake report alleging abuse of an 8 year old girl at St. Paul Parish in St. Francis by Budzynski in 1966-1968. Her parents knew and did nothing. (24067-24068)
- 9/12/06 Amy Peterson's interview with a man who had been propositioned by Budzynski as an 18 year old college student. Budzynski rubbed the man's chest under his shirt after the two had been drinking. (30186)
- 3/15/11 Sexual abuse intake report alleging abuse by Budzynski of an 11 or 12 year old girl in 1966-1967. (31045)
- Undated Information on Budzynski. He is currently being monitored and has restrictions, the District Attorney has access to his files, in 1994 he admitted there were more than 12 victims, since 1994 there have been more 3 reports from victims abused 20-30 years ago, he has been laicized. (29816)
- Undated Summary of Budzynski's sexual contacts from 1941-1987. Lists over 42 potential victims, as well as some adults. He was attracted to friends in seminary and boys he worked with while in seminary, but denies any sexual contact at that time. Budzynski himself was abused as a child. His first abuse as a priest was in 1965-1966, but it is unclear when this was first reported. In 1969-1971 he took pictures of boys in the nude and went to a psychiatrist without telling the Archdiocese. He was placed on leave in 1971-1972. In the summers of 1972 and 1973 he was at the University of San Francisco and parents there reported him

and asked him not to contact their children. Reports continue to 1987. (23888-23889; 23890)
