1992	The accusation by "A" against Wenig accompanied "A's" accusation about sexual assault by another priest as well. The case was investigated and there was sufficient evidence that the sexual assault by the other priest had occurred but no sexual contact by Wenig was described. No action against Wenig taken but he was also named, at advice of counsel, in a settlement for the abuse case.		
2002	The 1992 report was submitted to an independent commission reviewing all accusations against priests. The "A" case was determined to be the only accusation against Wenig and it involved inappropriate behavior and poor judgement but did not involve any sexual contact.		
2011	More reports (B, C) surface through Chapter 11 claims. Wenig placed on administrative leave while preliminary investigation conducted; placed under orders not to exercise public ministry
