Moving Funds from Restricted to Unrestricted

If a parish has an endowment or other type of restricted fund that allows a portion of it to be transferred over to parish operations (respecting the nature of the restrictions), then that transfer of funds needs to be reflected in the parish accounts. It should show as income to the parish's operating budget. Any expenditures of those funds should be recorded as expenses. These restricted funds become another source of operating income once the transfer takes place.

Showing Copyrighted Films in a Parish Setting

<u>Here is a good guide for showing copyrighted films in a parish setting.</u> This is not an official resource, but it is well-written, and linked to by other diocesan websites.

Somewhat surprisingly, there is not a copyright exception for churches or other non-profit organizations, even if the entity is not charging admission to the film showing. Note how narrow the education exception is; it doesn't offer much help to parishes.

The safest route to avoid potential legal hang-ups would be to obtain a license before showing a copyrighted film. For one-time licenses, Swank Motion Pictures (for studios other than 21st Century Fox) and Criterion Pictures (for 21st Century Fox Films, although this could change in the future with the announced Disney acquisition of the film and television division of 21st Century Fox) are the best bets. For more regular uses, Church Video Licensing offers licensing packages.

The next question that I am typically asked is how likely it is that a parish would be caught for showing a copyrighted film without first acquiring a license. I understand that this happens a lot, both knowingly and unknowingly, and that many entities do not get caught. However, I don't think this would be a good justification for engaging in such a practice. Fines for copyright violations can be very expensive and the fining process can be very time-consuming and intimidating. As such, I would advise all parishes to take the appropriate steps to comply with the requirements of copyright law when showing films for parish functions.

Please note that not all films are under copyright. Many older films exist in what is known as the "public domain". These films can be shown freely by anybody without a license.

Good Friday/Holy Land Collection

The Good Friday collection for the Holy Land should be submitted on a single check and not combined with other items. 100% of these donations are transferred to the Commissariat of the Holy Land.

Alternative Natural Gas Supplier

It has come to our attention that in the past few months a natural gas supplier, WoodRiver Energy, LLC, has approached several parishes and schools in the Archdiocese of Milwaukee marketing their services as an alternative supplier of natural gas. This company is not promoted or endorsed by the Archdiocese of Milwaukee. According to WE Energies, this company is not an approved marketer of natural gas to WE Energies customers and they are not able to distribute natural gas using the WE Energies infrastructure without becoming an approved marketer. WE Energies lists approved natural gas marketers on their website (https://www.we-energies.com/business/natgas/marketerlist.htm) and WoodRiver Energy, LLC is not currently listed. WE Energies has informed us that if a customer changes suppliers of natural gas to one of the approved marketers, the customer will continue to be billed by WE Energies for use of the pipe and meter infrastructure servicing the end user. This is in addition to receiving a bill from the alternate gas supplier. We recommend continuing to work with WE Energies for your gas and electricity needs. If your organization is approached to switch energy providers, the Parish and School Financial Consulting Office is available to assist in the decision making process.

Excel Tip

Excel allows you to copy data from the cell above the current cell using two shortcuts: Ctrl+" (quote mark) and Ctrl+' (apostrophe). For example, enter the number 12345 in cell A4. Move to cell A5 and press Ctrl+" and 12345 appears in cell A5. Go to cell A6, type ABC and press Ctrl+"; you end up with ABC12345 in the cell. Ctrl+" retains the formatting (numeric values, including dates and times) of whatever is being copied, but Ctrl+' does not. For example, if cell A5 contains the formatted value 12.34% and you position the cursor in cell A6 and press Ctrl+", your result is 12.34%. If you use Ctrl+' your result is 0.1234. Give them a whirl!
