# St. Andrew Parish DEAF RELIGIOUS EDUCATION MINISTRY SHARING THE GOOD NEWS



The gift of **wonder and awe** are just one of the seven gifts unleashed on all the students who were confirmed in the spring. That gift is what I have been focusing on lately as I look back and update you on the year of Deaf Christian Formation at St. Andrew's.

Wonder and awe in action starts with the elementary students! Sharing the story of our salvation with these children is an extraordinary opportunity. Many of the stories are first time stories of Jesus' earthly life shared with them, and of God's love for us. The gospel truths we have heard since we were little are being shared with many of them for the first time. My favorite class this year with them was also the one that incorporated our annual Safeguarding lesson. The goal was teaching respect for God who is the King of everything on earth and in heaven. He is superior! Yet our mighty King loves us so much that He calls us His children.

They are children of the most important King! Which means each of them truly are princes and princesses. Students received crowns and wore them on their head in royal fashion as God's own precious children. That recognition moment when the children gained a respect for God's majesty and a beginning awareness of how much God loves us was spine tingling. And that is how the journey went all year. Elementary classes have been exciting faith adventures that have the kids' heads spinning.



Our middle school students continue on that journey more in depth as they come to marvel at the teachings of Jesus while he lived on earth. They are always thirsting for more. Opening the eyes and hearts of the children to the astonishing power of God's love...it doesn't get old. The Good News is often late breaking news for the kids.

Probably our biggest excitement was having six deaf students get confirmed this year by Archbishop ListECKI. During our retreat and throughout the year we learned about the gifts of the spirit, (including wonder and awe) defending our faith, service and leadership.

Having six deaf students Confirmed is a pretty impressive number!

In Bob Ayers book *Deaf Diaspora: The Third Wave of Deaf Ministry* he writes, "Also note that having seven Deaf young people in one ministry is a significant number. I suggest that people unfamiliar with ministry to Deaf teenagers use a mechanical factor of "times ten"— meaning the effort to attract and involve Deaf teenagers is somewhat equivalent to connecting with ten times that many hearing teens. This size Deaf teen ministry would be similar to having seventy secondary school students in a hearing youth group program. That would be a fairly impressive number in most churches or ministries."





The students gift the teachers with renewed fascination of how awesome God is! At the end of teaching a lesson we step back with astonishment and realize that the truth about our salvation story and how special we are, along with our purpose in life should not be 'been-there, heard-that' stories where the re-telling does not faze us. Our status should be burning with the gift of wonder and awe.

There are many more stories to be told that the students have never heard before. We pray that the students' early faith formation will be shaping them to become future Deaf Catholics who lead others to faith. We pray that the gifts of the Holy Spirit grow stronger within each of these children ... and within all of us.

I find myself filled with admiration and gratitude for a small group of people who felt God calling them to share their faith with these students. Father Christopher Klusman joined me every Wednesday as we team taught all the grade levels. Parishioner Roxy North supervised the evening bus that transports the kids to religion classes from Wisconsin School for the Deaf and served as an assistant. Rene Ambrose, a WSD teacher from Mukwonago, prepared one of our Confirmation students in the dorm at WSD. This student was in a wheelchair and could not join her Confirmation class on the 3rd floor for instruction. Parishioner Peg Stachowiak also taught one-on-one in the dorm of WSD for an elementary student, also unable to join his class on the 3rd floor due to his physical challenges. Additionally Peg has been working on a long term sewing project for the Christian Formation Department by making Biblical scenes come to life in the form of banners to enhance the department and to use as another visual teaching tool.

This update of the successful year we had in the Deaf Ministry at St. Andrew is my thank you note to the parish for your support and dedication to the amazing task of raising up the faith of our Deaf students among us whom we serve.

### Religious ASL Week: Another Exciting Opportunity!

Wow, aren't we lucky for this is building up to be a nice summer FULL of many learning and spiritual opportunities! This summer has a really exciting workshop during the week of July 15 to 20<sup>th</sup>: RASL (Religious ASL) Week! I attended the event during the Summer of 2006 during my summer vacation as a seminarian. I attended because I was fascinated at it being a workshop that focuses on three kinds of groups: the Deaf ASL lectors, sign language interpreters, and priests, deacons, and seminarians (who are hearing that work (or want to work) with the Deaf community. The Deaf lectors are members of the Deaf Catholic community who sign the readings during Mass, such as the 1<sup>st</sup> reading, Responsorial Psalm, and/or the 2<sup>nd</sup> reading. At different parts of the day, my presenters ranged from Monsignor Nelson of the Rockford, Illinois Diocese, Deacon Patrick Graybill of the Rochester, New York Diocese, and then-Pam Sommers (now Pam Conine) of the Archdiocese of Milwaukee. Deacon David Sommers taught the priests, deacons, and seminarians.

The workshops really helped me learn how to be a more effective and better lector, as well as improving my understanding of our precious Catholic Mass. There were opportunities to meet in groups to learn how to prepare well on signing the readings. We were introduced to a whole variety of resources (books, etc.) on helping us to understand better the readings. We learned how to be an effective lector, such as how to move our arms, what *not* to do, and etc.

In a different workshop group, the sign language interpreters learned how to improve their sign language interpreting skills. I remember during Mass, on the far left side and far right side of the altar, there would be registrant sign language interpreters trying out their new skills that they learned at this

workshop. It was really neat to watch. Plus, the interpreters learn voicing techniques too! It was really special because of this rare opportunity for them to practice, as well as to gain valuable feedback from their instructors, other interpreters, Deaf community, as well as the priests, deacons, and seminarians. Who could find an unique opportunity anywhere else?!

You were probably wondering what was going on with the hearing priests, deacons, and seminarians? At the time, Deacon David Sommers was their teacher on learning ASL (American Sign Language). The nice thing about this class is that the hearing priests, deacons, and seminarians learn ASL with religious signs. This is not something you would find in regular classes offered in American Sign Language in colleges, universities, or private lessons. And, not only that, you would see the priests, deacons, and seminarians try out their new signing skills at the Mass! I remembered how awesome it was to meet them on the first day, only to be surprised on how they've improved already at Mass a few days later!

One cool thing that I never forgot is our meals. Even though we had hearing registrants, they are not allowed to talk. They have to practice really signing with everyone else. When I was in contact with some of the hearing after RASL week, they told me how valuable that experience was because it made them get better. That is what we mean by an "immersion" experience as they learn what it feels like to communicate only in sign language and to understand what it feels like to be Deaf.

I hope you can register for RASL Week. It will be at a beautiful retreat center (the Bishop Lane Retreat Center) near Rockford, Illinois. It is a workshop that you don't want to miss! Try to go there with your sign language interpreter(s) and/or your hearing priest(s), deacon(s), and/or seminarians(s)!

### My Experience at Cursillo #59

One source of great news is that this October 4-7, 2012, the Archdiocese of Milwaukee is very blessed to have the National Deaf Cursillo #64! I write this to encourage you to think about going because it's a wonderful experience. Plus, you wouldn't have to pay an expensive airplane ticket for you can drive (or find someone to ride with) to Cursillo #64 near Milwaukee! How often does this happen? Not often (the last time the National Deaf Cursillo was here was August 1982)! 30 years ago!

The Cursillo that I attended was Cursillo #59 in October 6-9, 2005. It was at DeSales Center in Brooklyn, Michigan. I went because many Deaf Catholics told me how inspiring and wonderful it was. One thing that impressed me about the National Deaf Cursillo is how it transformed many Deaf people's lives. Several Deaf people told me that they love the Church and are active ministers because of their experiences during the Deaf Cursillo! Before they attended the Cursillo, they felt not completely happy, had lost a sense of purpose and direction, and/or didn't really understand God's will in their lives. Cursillo changed all that

for them. They found happiness through God's love of them, found or began to understand God's will in their lives, and understood better what they can do for and with the Catholic Church.

At the Cursillo #59, I truly enjoyed meeting many different Deaf Catholics from all over the country. They were of all different ages. I enjoyed chatting with them. We watched many exciting workshops about our beautiful Catholic faith in sign language and did team activities. We even did prayer services and Mass together, as well as the Sacrament of Reconciliation/Confessions. One of my fond memories of Cursillo #59 was my experience with Fr. Jim Hall, one of our deaf priests, who passed away last June 2006. It was certainly a powerful several days for me that really made me feel happy to be a part of it. It made me feel uplifted and helped to strengthen my relationship with God and the other Deaf Catholics.

## Ephpheta Sodality of St. John the Baptist Delegate Report

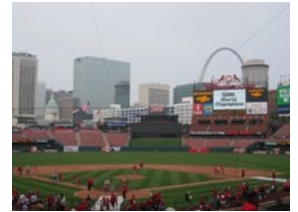

Dear Friends in Christ,

Anytime I anticipate that there will be news about our Chapter 11 proceeding, I want to be sure to connect with you to explain what we are doing and why we are doing it.

You'll recall that more than 570 claims were filed in the bankruptcy proceeding and in order to prepare the Archdiocesan Plan of Reorganization, it is important for us to know which of these claims qualify for compensation under the bankruptcy laws. The only way to determine this is by filing what is called an "objection to claim" motion with the court. If a particular claim or type of claim is not going to be allowed, then people need to know this.

For example, some claims have been filed that simply should not qualify for financial compensation from the archdiocese. These claims describe incidents that are not sexual abuse or make allegations against a religious order priest or a lay person who was not an employee of the archdiocese. Others are claims by individuals who previously reached a legal financial settlement with the archdiocese. In addition, the abuse claims are past the statute of limitations.

Some of these motions have been ruled upon by the bankruptcy judge and they have been appealed to the district court. Decisions on other motions are scheduled to be determined by the bankruptcy court

sometime in August and even then we won't have a final answer because those decisions will likely be appealed.

In an attempt to move the proceeding forward, the archdiocese has filed what is called a "motion for withdrawal of the reference" with the federal district court. In the motion, the archdiocese asks that the seven objections to claim motions currently with the bankruptcy court be heard and decided by the district court, which is the same court that hears any appeals of decisions by the bankruptcy court. There are three main reasons for doing this.

First, it will speed up the case and promote judicial efficiency. By August, more than a year-and-one-half will have passed since the archdiocese filed its Chapter 11 petition. Since the district court will hear the appeals anyway, we might as well move things along and let the district court answer these questions now -- it's simply faster this way.

Second, it will save money. Without a definitive decision, the Chapter 11 proceeding will cost more -- both in time and money. The archdiocese has limited resources and the longer it takes to determine what claims are eligible, the less money will be available.

Third, it will assist with the determination of which of the other claims are eligible for compensation. This is the most important aspect to be determined so a Plan of Reorganization can be drafted, allowing us to carry on the essential ministries and

services of the archdiocese and pay what we can to eligible claimants.

Some will criticize us for doing this, saying it is an attempt to deny abuse survivors justice, and that every claim, regardless of what it alleges or how old it is, should simply be paid. The reality is that in each of these circumstances these types of claims are simply not allowed under bankruptcy law.

Some will say we should simply negotiate or go to mediation to settle all the claims. We could (and you'll remember that I initiated mediation to settle the existing claims prior to filing Chapter 11), but that would not change the priority of determining which claims are eligible for compensation. Settling ineligible claims is an injustice to abuse survivors with eligible claims.

However, I remain committed to providing therapy and counseling for abuse survivors of diocesan priests, regardless of whether their claim is eligible for compensation in the Chapter 11 proceeding and I will only agree to a Plan of Reorganization that maintains our ability to provide therapy and counseling assistance to these abuse survivors. The archdiocese will ask the court to allow us to create a fund that would provide resources for therapy and counseling as long as such a need exists. We do this not because we are required to do so, but because our faith calls us to do so. I will insist that our ability to continue counseling and therapy for abuse survivors remains intact.

It is the archdiocese that, for decades, has voluntarily provided therapy and counseling assistance to survivors regardless of when abuse occurred; that established new standards for sexual abuse prevention; that dealt with perpetrators by removing them from ministry and publicly posting the names of clergy with substantiated allegations; and that requires safe environment education -- all higher standards than any other institution in our society and all standards I pledge to continue.

I apologize for this LOVE ONE ANOTHER being longer than a regular message however, I wanted you to be aware of why in our legal process we pursue this course.
