### **Power School Software**

For those of you who signed up for Power School, you'll be receiving a separate invoice from the Archdiocese of Milwaukee in October. The Power School invoice will be based on your actual enrollment and you are receiving the benefit of a large group rate. Please adhere to the payment due date on the invoice. Note that this is a new billing and is separate from the annual School Assessment.

## **Special Events Insurance Coverage**

Often when a private party/outside group wishes to host a special event at a parish, the outside group incorrectly presumes that their individual homeowner's or umbrella policy will provide the

liability coverage necessary for the event. The best response to any person suggesting that they do not need to purchase the special events coverage is to have their homeowner's insurance agent contact Catholic Mutual Group at 262-255-6906. The individual's insurer must be willing to name the host parish as "an additional insured." Including the host parish as a "certificate holder" does not protect the parish from claims the way Special Events coverage does. The cost of special event coverage is \$95.00. Our friends at Catholic Mutual Group are happy to answer any questions about special events coverage and adequately protecting your parish. Please call them directly at 262-255-6906.

## **Excel Tip**

Do you want the print/page set-up settings the same from one worksheet to others? Here's how it works. Select the source sheet that contains the settings you want to transfer (this worksheet must be displaying on your screen). Then select the target sheet(s) you want to update (press [Ctrl] and click each sheet tab). Select Page Setup from the File menu and click OK. The print settings are now the same for all the sheets selected.
