# Safe Environment & Catholic Mutual Training Videos

Catholic Mutual Group has developed a new software platform that will combine and replace the platforms currently being used for the Archdiocese of Milwaukee's Safe Environment Program and Catholic Mutual training videos including BE SMART DRIVE SAFE, as well as transportation, safety, and business best practices videos.

The new CMG Connect platform will be live on July 1, 2016. **The existing platforms will be down from June 23 through June 30** to facilitate the transition. Do not schedule any training sessions during this time.

### **Casino Fundraiser**

Recently, the Office of Parish & School Financial Consulting was asked to provide guidance as to the legality of holding a "Casino Night."

The federal Department of Justice ("DOJ") is the agency which oversees the legality of gambling which is not otherwise allowable by statute in the State of Wisconsin.

Generally, only bingo and raffles are considered legal in the State of Wisconsin and then, only if sponsored by a qualified organization of religious, charitable, service, fraternal, veterans or otherwise tax exempt nature.

The fundamental issue in holding a fundraising event which will include casino-style or Las Vegas-style games will be to do so in a manner which is NOT considered gambling and, therefore, not illegal. There are three material components to gambling: consideration (cost to play), chance and prize. If you can eliminate just one of the three, the event will not be considered gambling. Obviously, the second two components will be virtually impossible to eliminate and still leave the event with much of a possibility of fundraising success. Virtually any game you offer will need to be based on chance and award of a prize to attract participation. So the key will be how you charge a cost to attend your event. We cannot provide legal advice but want to offer a few suggestions:

- 1. Try to make the gaming aspect of your event "secondary" in importance. For example, have a buffet and sell tickets to the dinner with playing the games not contingent on a separate fee;
- 2. Promote the gambling-like activities as "casino-style" or "Las Vegas-style;"
- 3. Include a base level of chips along with the purchase of a ticket to the buffet or event and do not use real US currency in the play of games;
- 4. Do not be restrictive with who can play by limiting players based on age or a specific cost to participate;
- 5. Play for fun. Have prizes be based on redemption of chips.

This type of fundraiser certainly is possible and there are businesses whose services you will likely wish to use to manage the games but be careful to promote the event properly to avoid it being interpreted as illegal gambling.

### **Excel Tip**

Ever try to cut and paste info, only to find after you done the 'cut' you forgot to insert a row for it to land? Try using "Insert Cut Cells." After you cut (Ctrl x), go to the line below where you want to insert the information, then use **Ctrl Shift** =. This will also remove the blank line from the source of the cut. If you have customized the ribbon in Excel and have added the icon for Insert Cells, that icon will change to "Insert Cut Cells" once you do the cut.
