| PRAYER & SACRAMENTS | | |
| Sunday and Daily Mass | Yes, with attendance limited by your ability to effectively maintain social distancing in relation to church capacity. Strict adherence and vigilance with cleaning and sanitizing protocols. | |
| Wearing of Face Coverings | Best practice - and the expectation - is to wear a face covering, not only for personal protection but to be respectful of others. Priests, deacons, and extraordinary ministers of Holy Communion should wear face coverings when distributing Communion. | |
| Reception of Communion | Reception of Communion is recommended in the hand only. Reception on the tongue is allowed in SPECIAL circumstances, under the priest/deacon/parish director's discretion. If reception on the tongue is allowed, it should be done AFTER those who have received in the hand. One designated distributor is preferred. Alternating distribution between hand and tongue is not allowed. If the number receiving on the tongue is small (less than 5 individuals), distribution could take place after Mass, in the sacristy or other appropriate area. | |
| Lay Eucharistic Ministers | Yes, Eucharistic Ministers may be used to distribute Communion, following the same Guidelines for Clergy. | |
| Choir/Singing | One cantor is allowed, but no singing choirs, and communal singing should be minimized. Bell choirs are allowed with social-distancing and no shared bells. | |
| Music | Musicians should wear face coverings and social distance. No wind or brass instruments. | |

| First Communion Celebrations | Yes, with attendance limited by your ability to effectively maintain social distancing in relation to church capacity. Strict adherence and vigilance with cleaning and sanitizing protocols. |
| Youth Confirmation | Yes, with attendance limited by your ability to effectively maintain social distancing in relation to church capacity, following the Archbishop's Mass Directives. Strict adherence and vigilance with cleaning and sanitizing protocols. |
| Adult Confirmation | May 23, 2021, Pentecost Sunday at the Cathedral |
| Weddings | Yes, with attendance limited by your ability to effectively maintain social distancing in relation to church capacity, following the Archbishop's Mass Directives. Strict adherence and vigilance with cleaning and sanitizing protocols. |
| Funerals | Yes, with attendance limited by your ability to effectively maintain social distancing in relation to church capacity, following the Archbishop's Mass Directives. Strict adherence and vigilance with cleaning and sanitizing protocols. |
| Funeral Wakes | Yes, with social distancing protocols and strict adherence to cleaning and sanitizing protocols. |
| Reconciliation | Yes, with social distancing and privacy protocols. No confessional use. |
| Communal Penance Services | Yes, with social distancing protocols and strict adherence to cleaning and sanitizing protocols. No general absolution. |
| Baptisms | Yes, with attendance limited by your ability to effectively maintain social distancing in relation to church capacity, following the Archbishop's Mass Directives. Strict adherence and vigilance with cleaning and sanitizing protocols. |
| Anointing of the Sick | Viaticum for those who are actively dying. Yes, for individual requests for anointing, following State guidelines and taking extra hygiene and cleaning precautions. |
| Anointing of the Sick Services | No public communal celebration of the Sacrament of the Sick. |
| Individual Anointing of Non-Covid-19 Parishioners not in a Hospital or Nursing Home | Yes, taking extra caution with hygiene and handwashing, following the guidelines available <u>here</u> . |
| Visiting/Taking Communion to Parishioners who are Homebound | Yes, clergy and limited number of parish-trained lay ministers only, taking extra caution with hygiene and handwashing, following guidelines available here . |

| Visiting Parishioners/Taking Communion into Hospitals, Nursing Homes, Assisted Living or Rehab Facilities and Senior Living Complexes | Yes, clergy and limited number of parish-trained lay ministers only, taking extra caution with hygiene and handwashing, following facility guidelines. |
| Processions | Yes, practicing social distancing and wearing face coverings. |
| Eucharistic Adoration | Yes, at the pastor/parish director's discretion, with attendance limited by your ability to effectively maintain social distancing in relation to church capacity. Strict adherence and vigilance with cleaning and sanitizing protocols. |
| Rosary or other Communal Prayer | Yes, at the pastor/parish director's discretion, with attendance limited by your ability to effectively maintain social distancing in relation to church capacity. Strict adherence and vigilance with cleaning and sanitizing protocols. |
| Children's Liturgy of the Word | No |
| Distribution of Holy Water | Yes, in individual containers or automatic dispensers. |
| Use of Holy Water in Fonts | No |
| Funeral luncheons/receptions or wedding rehearsal receptions, etc. | No |
| Worship Aids | Single use worship aids are allowed. Provide a disposal bin at each exit for collection after each Mass or prayer service, or instruct worshippers to take worship aid home with them for disposal. |
| Distribution of paper bulletins | Yes, upon exit only. Distributed by ushers wearing masks and gloves while keeping as much social distance as possible. |
| Parish offices open to the public | Yes, with social distancing protocols. |
| Parish staffs returning to normal operations | Yes, with social distancing protocols. |
| Pastoral Council and parish and school committees | Yes, with social distancing protocols. |

| Religious Education (child and youth, K-5), 2020-2021, Beginning in Fall | Yes, in-person formation is preferred, with social distancing and less than 50 in attendance. Small groups encouraged. For family programs, social distancing by household. Be ready to offer alternatives and support for families who wish to form their teens at home. | |
| RCIA/Adult Confirmation Process | Yes, online/virtually or in person, with less than 50 people, with social distancing and cleaning protocols. | |
| Middle/High School Religious Education & Youth Ministry: Sessions at Parish | Yes, in-person formation is preferred, with social distancing and less than 50 in attendance. Small groups encouraged. For family programs, social distancing by household. Be ready to offer alternatives and support for families who wish to form their teens at home. | |
| Youth Ministry: Same day retreats and gatherings, etc. | Yes, if all participants are local and less than 100 people in attendance, with social distancing protocols, a parent consent form or permission slip from all participants, and ensuring all Safe Environment requirements are met. No overnight events, no meeting in private residences, no shared meals. Individually wrapped meals okay (i.e. box lunch). Use of bus transportation is allowed if social distance seating is followed. | |

| Parish Support Groups, AA meetings, etc. | Yes, with attendance limited only by your ability to effectively maintain social distancing in relation to meeting space capacity. Strict adherence and vigilance with cleaning and sanitizing protocols. | |
| Parish Sports, Adult Athletic Programs, Open Gyms, T-ball, etc. | Yes, with proper safety protocols. | |
| Parish Golf Outings | Yes, with social distancing and a safety plan. Individual or pre-packed meals, no buffet service. Outdoor dining only. | |
| Meal Programs, Food Pantries and other social outreach | Yes, following state guidelines and taking extra hygiene and cleaning precautions, with social distancing protocols. | |
