## **Historical Note**

St. Albert Congregation was founded in 1953 and merged with St. Nicholas Congregation and Holy Redeemer Congregation in 1991 to form Blessed Trinity Congregation. The parish was located in the northwest section of Milwaukee in an ethnically diverse area. The parish school closed after the 1989/90 school year.
