Historical Note

"Where There Is A Will, There Is A Way" is a motto which motivated some 31 Lithuanian Catholics to whom the founding of St.Casimir's can be traced in the year 1903. The first meeting of the Lithuanian immigrants was held January 3, 1903. Thirty one members joined and officers were elected. It was named the St. Casmir's Society, in honor of St.Casimir, the patron saint of Lithuania.

In August, 1913, Rev.Vincent Slavinas was appointed to serve St.Casimir's Church. On August 24, 1913, the church was blessed by Father Meyer. Though St.Casimir's was founded by Lithuanian immigrants, non-Lithuanian's membership increased yearly. Many members served the parish as lectors, ushers and Parish Council members. On May 15, 1996 St. Casimir's was named as one of the recipients of a Century Building Certificate awarded by Preservation Racine, Inc.

In 1998 St. Casimir Church merged with four other Racine parishes: Holy Name, Holy Trinity, St.Rose and St. Stanislaus.

Scope and Content *a brief description of the types of materials in the collection.*

This seven boxes collection contains St.Casimir's Church financial records and reports in paper and floppy disks format, insurance information, collaboration work materials, incorporation documents, bulletins and correspondence. Part of the collection documents lights up the property purchase, repairs and renovation. The content of the two boxes are the marriage case files. Box 5 contains oversized materials including an original indulgence given to St.Casimir's Church by Vatican.
