## **Historical Note**

St. Patrick Parish was organized in 1855 in response to a growing number of Irish Catholics in the Fond du Lac area. Land for the church was donated by John B. Macy. The church building was constructed by hand by the parishioners and took nearly 8 years to complete. Rev. James Colton served as the parish's first pastor. The parish provided religious education early on, even though there was no formal school building until 1938. The sister's convent was also built in 1938. C.C.D. classes and adult education were also offered through the church. St. Patrick parishioners also participated in parish organizations such as the Altar and Rosary Society, The Holy Name Society, the Young Ladies' Sodality and youth groups. The parish also held memorable St. Patrick's Day celebrations. In 2000 St. Patrick merged with five other parishes in the Fond du Lac Area (St. Joseph, St. Louis, St. Mary, St. Peter and Sacred Heart) to form Holy Family Parish, Fond du Lac.

## **Scope and Content** *a brief description of the types of materials in the collection.*

This collection consists of parish records. Administrative records include copies of the Articles of Incorporation and By-laws, insurance and property records, Parish Council records, and financial reports. In addition there are records related to the parish building. There are Parish bulletins from 1965-1998 (missing 1969-1971, 1973). There are some records of parish committees and societies. Also included are records that relate to the merging of parishes in the Fond du Lac area.
