

The following is the finding aid for the St. Joseph Parish, Fond du Lac collection located at the Archdiocese of Milwaukee Archives. A finding aid is a catalog tool used in archives that briefly describes the material found in a collection. Access

Open/Unrestricted except for financial records, census records, employee records, parishioner correspondence and marriage case files.

Historical Note

St. Joseph parish was established in 1871 and the first pastor was Father George Willard. The parish formed when several ethnic groups (Irish, German, French) comprising that congregation broke away from St. Louis parish to form their own parishes in Fond du Lac. The French parishioners that left in 1871 took the name St. Louis with them so the remaining congregants renamed the parish St. Joseph. The "new" parish was predominately Irish in ethnicity but was also very inclusive to other ethnic groups.

The parish was officially incorporated in 1877. A church was constructed from 1874-1877, but burned down on September 24-25, 1908. A new church building was quickly started and then completed in 1910. The first school at St. Joseph opened in 1928. St. Joseph parish closed in 2000, after merging with five other Fond du Lac area parishes to form Holy Family parish. The other parishes involved in the merger included St. Peter, St. Mary, St. Patrick, St. Louis, and Sacred Heart.

Scope and Content *a brief description of the types of materials in the collection*. This collection is divided into four series: Administrative, Financial, School, and Marriage Case Files.

The Administrative Series includes bulletins, census records, historical materials such as newspaper clippings and photographs, and various committee records (including Parish Council). The Financial Series includes annual parish financial reports, estate records, property records, and payroll records. The School Series consists of the records of some various school committees and records related to school consolidation.
