Historical Note

St. Mary Help of Christians was founded in 1904 after Archbishop Sebastian Messmer requested Father Alois Kastigar to organize a parish for the Slovenian people of Milwaukee. On May 27, 1904 the congregation was formally incorporated under the laws of the State of Wisconsin. The parish was provided a church building with a rectory at 5th and Walnut in Milwaukee where they remained until 1907 when a new church was built in West Allis. The completed church was blessed on May 31, 1908 by Bishop James Trobec and remained the parish's home until a new church was built in 1967.

In 1948, a school was constructed with classrooms for grades 1-8. The first classes were taught in 1949 by three sisters from the Congregation of St. Agnes. Due to increasing costs and declining enrollment, the school closed after the 1993 school year.

For a number of years the parish was home to the Tridintine Mass community, but due to deomographic trends, declining, membership, and depleted financial reserves, the church closed in 2007. The final Mass was celebrated on February 18, 2007.

Scope and Content *a brief description of the types of materials in the collection.*

This collection contains various records concerning both the church and the school including membership cards and other parishioner registries, class lists, correspondence, parish meeting and board of directors meeting minutes, financial records, announcements/bulletins from 1938-2005, historical information, as well as building information for the church, convent, and school buildings, including information regarding asbestos removal that was conducted in the 1980s.
